STARTERS

Chicken Lollipops

Smoked chicken drumsticks coated in our house rub with our BBQ glaze

Merry Balls

Seasoned sausage meat wrapped in smoked bacon, smoked in our house rub and a cranberry BBQ glaze

Halloumi Bites (vegetarian)

Deep fried bites of halloumi cheese seasoned, with flour and paprika

Cauliflower Fritters (Vegan)

Cauliflower florets coated in our special vegan batter and deep fried

All served with our Redneck BBQ sauce

MAINS

Smoked Turkey Drumstick

With a cranberry BBQ glaze and served with skin on chips and xmas slaw

Slow Smoked Beef Brisket

Served with skin on chips and xmas slaw

BBQ Pulled Jackfruit Bap (Vegan)

Served on a soft white bun with lettuce, and served with skin on chips and xmas slaw

1/2 Rack of Pork BBQ Ribs (£2 supplement)

Served with skin on chips and xmas slaw

PUDDINGS

Triple Chocolate Brownie

Warm milk, dark and white chocolate brownie Served with Kelly's Cornish vanilla bean ice cream

Apple & Blueberry Crumble (vegan)

Bramley apples and blueberries with a biscuit topping Served with vegan ice cream

Christmas Pudding Sundae

Spiced rum chocolate sauce and Kelly's Cornish vanilla bean ice cream

Allergens

If you require any assistance with regards to allergens please inform a member of staff, and we can aid you in your meal choices.

Under 18s

Under 18s are only allowed on the premises when accompanied by a parent or guardian. No one under 18 will be served alcohol, any person found to be supplying alcohol to an under 18 will be asked to leave the premises. We operate challenge 25 policy, so people under the age of 25 may be required to show a valid form of ID as proof of age. No under 18s are allowed on the premises after 9pm

Bar Service

Both bars will call last orders at 23:45 and close at midnight, unless pre-organised. Only drinks bought from the premises are permitted, anyone found to be bringing their own alcohol in from off-site will have it confiscated

Cancellations

Any cancellation will be subject to loss of deposit, if cancelling after full payment has been made, the following will be refunded depending on time frame before booking date.

> 1 week – 50% refund less initial deposit

< 1 week – 25% refund less initial deposit

< 48 hours– No refund

Cloakroom

Unfortunately we are unable to offer a cloakroom service, the respective owners must look after all their belongings. We do not take any responsibility for storing or loss of property .

Deposit

A £10 non-refundable deposit per person is required to secure a booking.

Disabled access

Unfortunately due to the age/nature of the building we are unable to offer wheelchair access to our downstairs area and/or disabled toilets.

Late Payment

If payment is late your booking will be classed as unsecured and may be booked by another group. Lost Property Any property that is found/handed in will be recorded and kept for up to 7 days after the event. After the 7 day period the belongings may be disposed of / destroyed.

Opening Hours

Our premises opening hours for Christmas parties will be 12:00 – 23:00 for admission. No entry to the premises after 23:00, the premises will close at 00:30 at which point guests will be required to leave. A smoking area is provided in front of the premises and this will be available until 23.30 only.

Recorded Music

All recorded music will be set at a level by the premises management; music will be terminated at 00:00, unless pre-organised

Payment Schedule

Full payment must be received at least 4 weeks prior to the booking.

Public Nuisance
